

Astro Gold Pro Reports

Software & Intellectual Property License Agreement

This Software & Intellectual Property License Agreement (“Agreement”) governs the use of the **Astro Gold Pro Reports software and report-generation system** (“Software”) provided by **Cosmic Apps** (“Company”, “we”, “us”, or “our”).

By downloading, installing, accessing, or using the Software, you (“User”, “you”, or “Licensee”) agree to be bound by this Agreement.

1. Grant of License

Subject to the terms of this Agreement, Cosmic Apps grants you a **non-exclusive, non-transferable license** to download and use the Astro Gold Pro Reports Software.

You may:

1. Use the Software to generate astrological reports.
2. Generate **unlimited reports** for:
 - Personal use
 - Commercial use, including providing reports to clients.
3. Distribute reports generated **directly from within the Software**.

All rights not expressly granted in this Agreement are reserved by Astro Gold.

2. Scope of License

The Software, including but not limited to:

- report structures
- text content
- interpretations
- algorithms
- layout templates
- design
- software code

are the **exclusive intellectual property of Cosmic Apps** and are protected by copyright, intellectual property, and international copyright laws.

This Agreement grants a **license to use the Software**, not ownership of the Software or its underlying intellectual property.

3. Permitted Use of Generated Reports

Users may:

- Generate reports using the Software.
- Provide or sell those reports to clients.
- Use reports in professional astrological consultations.

Reports must be **generated through the Astro Gold Pro Reports Software**. Users may not recreate, reproduce, or distribute report content outside of the Software environment except as reports produced by the Software.

4. Editing of Reports

If the Software produces reports in an editable format, users may edit those reports subject to the following conditions:

1. Minor edits and formatting changes are permitted.
2. If the user modifies more than 10% of the original report content, the user must clearly acknowledge that the report has been modified.
3. Users may not present significantly modified reports as being entirely authored by Astro Gold. **Example acknowledgement:**
“This report is based on Astro Gold Pro Reports software and has been modified by the practitioner.”
4. The author’s name and the attribution “A Report by Astro Gold” must be retained in their original form and must not be removed, altered, or obscured in any edited version of the report.

Editing reports outside of these parameters (4.1, 4.2, 4.3, 4.4, 4.5) will be in violation of copyright.

If the Software is in a non-editable format, no changes are permissible to any part of the program.

5. Prohibited Activities

Users may **not**:

1. Sell, share, sublicense, rent, lease, or transfer the Software to another person or business.
2. Allow another party to use the Software under your license.
3. Copy, reproduce, or distribute the Software itself.
4. Reverse engineer, decompile, or attempt to extract the source code of the Software.
5. Extract or reproduce report text or interpretation libraries outside of the Software.

Each license is intended for **one licensed user only unless otherwise agreed in writing by Cosmic Apps**. Allowing business/company employees to use your individual license would be in breach of this license agreement. They would need to purchase their own license.

6. Distribution of Reports

Reports created using the Software may be:

- Printed
- Delivered digitally
- Sold as part of astrological services

However, users must **not distribute the Software itself or any part of its internal report-generation system**.

7. Termination

Astro Gold reserves the right to terminate this license if a user:

- violates this Agreement
- distributes the Software unlawfully
- misuses the intellectual property

Upon termination, the user must cease using and uninstall the software.

8. Limitation of Liability

The Software and reports are provided “**as is**” without warranties of any kind.

Astro Gold shall not be liable for:

- any business losses
 - indirect or consequential damages
 - interpretation or use of astrological content produced by the Software.

Astro Gold may update or modify this Agreement at any time. Continued use of the Software constitutes acceptance of the updated Agreement.

This Agreement shall be governed by the laws of Victoria, Australia.
